General Rules

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH. UNITED STATES EQUESTRIAN FEDERATION RULES do not require the inclusion of full judging specifications in prize list and programs of approved shows, except classes not listed in the USEF Rule Book.

USEF MEMBERSHIP STATEMENT - Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

USEF SAFE SPORT STATEMENT - All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies

USEF AMATEUR CERTIFICATION FOR EC AMATEUR MEMBERS - EC amateur members, competing in amateur classes, must complete and sign a USEF membership application verifying they meet USEF amateur requirements. There is no charge. Membership must be completed online at usef.org

USEF MEMBERSHIP - Affidavits are no longer accepted for payment of non-member fees. Exhibitors must have a Competing Membership, either Life, Senior Active or Junior Active Member or pay a Show Pass Fee. See next paragraph.

USEF NON-MEMBER PARTICIPATION - If membership documentation is not submitted to the competition and the competition cannot verify such information, the exhibitor will be required to complete a Show Pass form and pay a non-refundable Show Pass fee of \$45.00. (GR1309.2.b) Show passes must be purchased online at USEF.org. A Show Pass is only valid for one competition and non-member participants (riders, drivers, handlers, vaulters, longeurs, owners, lessees, and agents) are limited to obtaining no more than one (1) Show Pass per competition year.

WDAA MEMBERSHIP STATEMENT - To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class or at

any Federation Western Dressage Licensed Competition persons must be active members of WDAA or pay a non-member fee equal to the price of an annual membership for each competition. Exception: WDAA membership or non-member fee is not required at a Lite Licensed competition. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownership, only one owner need be a Member or pay a non-member fee. The competition is responsible for listing either the active member or the owner that paid the non-member fee in the results. The competitions will be responsible for forwarding a list of the names of individuals who pay non-member fees at the competition to WDAA with the post competition report. Payment of non-member fees for the purpose of competing does not entitle the individual to any privileges of the WDAA membership.

SHARPS CONTAINERS - GR12104. Competition management must place a minimum of one (1) sharps container per competition, regardless of whether stabling is provided.

a. If stabling is provided, for every fifty (50) occupied stalls, one (1) sharps container must be provided for the disposal of needles and other disposable sharp instruments. These containers must be placed in visible, accessible, and convenient locations in barns housing competition horses.

b. Sharps Containers: A sharps container is made of puncture-resistant plastic with leak-resistant sides and bottom. It has a tight fitting, puncture resistant lid, which does not allow sharps to come out of the container. Sharps containers must be properly labeled to warn of hazardous waste inside the container. Sharps containers must not be altered in any way from its manufactured form, such as removal of security measures or drilling of the plastic. Sharps containers must be protected from the elements as to not collect rainwater

c. It is competition management's responsibility to dispose of contents of sharps containers when the container is three-quarters (3/4) full, in accordance with community guidelines for proper disposal methods. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100.00 for improper disposal of needles or other sharp disposable instruments.

d. If local law has more stringent requirements than the above, related to sharps containers or disposal, local law will prevail. Competitions that fail to place the required number of containers on the competition grounds or dispose of the contents properly will be considered in violation of the rules and may be subject to penalty as determined by the CEO or their designee and/or the Hearing Committee.

ENTRIES CLOSE JULY 7, 2025 AND MUST BE POSTMARKED NO LATER THAN JULY 7 to avoid late entry fees.

SPACE IS LIMITED FOR DRESSAGE AND WESTERN DRESSAGE TESTS. There will be a limit of 50 tests per division and space will be allocated on a first-received basis. You will not be guaranteed a space simply by meeting the registration deadline. Dressage and Western Dressage horse/rider pairs will be limited to a maximum of three tests per division. Management reserves the right to reduce this to two tests to accommodate more horse/rider pairs. Dressage

tests will begin no earlier than 8am Wednesday and Thursday. Late entries will be accepted only if ride times are still available.

LATE ENTRY FEES: Entries POSTMARKED AFTER the closing date of July 7, 2025 will be charged a flat fee of \$25 per horse which will cover all classes entered by the horse.

In extreme circumstances, and upon payment of a \$50.00 fee, in addition to regular entry fees, a post entry may be accepted into a class after the one (1) hour deadline has passed.

ENTRIES MUST BE IN WRITING and signed by the Trainer (if you do your own training, you must sign) as well as the owner and the rider/driver/handler. No entries will be accepted over the telephone. **ALL entries must be accompanied by the TOTAL ENTRY FEES, TOTAL STALL FEES, AND USEF FEES, payable in US dollars. All open checks on file in the show office will be closed and deposited at the end of the show. Entries must include a signed waiver and release of liability in addition to the entry form.**

There will be a \$50 fee charged in addition to any bank charges on all returned checks. Checks returned for any reason must be replaced by cash, cashier's check or money order. No one will be allowed to show if a bad check or handling fee is outstanding. An Exhibitor will be notified of the returned check and if not settled within 10 days will be turned over to USEF for settlement. Show Management reserves the right to require cash, cashier's check or money orders from any exhibitor who has had a check returned to the show by the bank. Personal checks will not be cashed at the show office or Canadian currency exchanged for US. Due to the number of uncashed checks, refunds of amounts less than \$20 will be credited as a sponsorship.

TBA CLASSES: Show Management has allotted space for a limited number of TBA (To Be Announced) classes. TBA classes may be any class on the AMHA, FRIESIAN OR ASB class list or that are recognized by USEF with the exception of dressage, cutting, reined cow or hunter/jumper. These classes may be placed throughout the schedule at the discretion of show management. The fee for a TBA class is \$50/class plus the class sponsorship and class entry fee. TBAs are awarded on a first come first served basis only and must be reserved by July 31, 2025 with the show secretary.

CHANGE IN ENTRIES: Where exhibitors, trainers or stables wish to make a change in entries in any class, they are required to follow the procedure of scratching the existing entry and making a new entry with the Show Secretary's Office. Such changes shall be treated as post entries and charged the post entry fee. In the event of injury to a horse (Veterinarian's Certificate is required); exhibitors may post enter another horse as a replacement but must pay the post entry fee.

FAILURE TO SHOW AN ENTRY: will constitute a forfeiture of entry fees, except with a Veterinary Certificate which must be filed with the Show Secretary prior to the first class in which the horse is not shown unless excused by the Show Veterinarian. A \$30 Office Charge will be made on all cancellations of entries. **NO REFUND ON STALLS WILL BE MADE UNLESS THE SHOW SECRETARY IS NOTIFIED 10 DAYS PRIOR TO THE BEGINNING OF THE SHOW** including classes cancelled

due to severe weather or other emergency. See USEF GR832 and USEF GR912. Refunds will be mailed approximately 30 days following the close of the show.

Show management may cancel or combine classes which have fewer than 3 entries.

Classes which have been combined may be split upon request IF at least 6 horses have been entered. The decision to split a class is at the discretion of show management.

This show will use the one-judge system. The Judge's decision in all classes will be final.

Cross entry from Morgan Classic Pleasure to Morgan English Pleasure and Morgan Pleasure Driving is permitted provided shoeing requirements are met.

HEADGEAR ALL riders must wear ASTM/SEI approved headgear with properly fitting harness in the following:

- All classes where jumping is required and when jumping anywhere on the show grounds
- Hunter Seat Equitation Classes
- Dressage riders when warming up for and riding in Dressage classes (exception: Western Dressage)
- Leadline Riders at all times when mounted

Protective headgear is acceptable in any other division or class without penalty by the judge. See GR801.

HEALTH REQUIREMENTS

COGGINS: ALL horses entering Washington must be accompanied by a record of a negative official test for Equine Infectious Anemia conducted within the past 12 months.

GR845 Equine Vaccination Rule 1. At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhino pneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian. 2. In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian documenting the horse in question received the vaccinations; name of the vaccines and date of vaccine administration. 3. In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration. 4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering

the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds.

The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested. 5. Competition Management may not amend or enhance vaccination requirements without prior approval of the Veterinary Committee.

GATE HOLD: must be requested prior to the start of a performance. It will be granted only when horse/rider are in consecutive classes and shall not exceed 3 minutes

SHOW OFFICE: will open at 12:00pm Tue, July 29. The telephone number of the show office is (360) 805-6711. There will be a \$30 office charge per owner.

THE EMERGENCY VETERINARIAN'S name and phone number will be posted on the Show Office door.

CAMPER HOOKUP: \$50 per night. There are 87 camper hookups available on a first PAID; first served basis. Vehicles parked in hookup spots but not hooked up will still be charged the hookup fee of \$50 per night. Please pick up your camper permit at the show office. Showers available.

STABLING POLICY: There are 312 10x10 permanent stalls with a five feet wide sliding door. ALL STALLS (for horses or tack) are \$160 each. Bedding: In lieu of having to purchase individual baled shavings, the show will be providing bulk shavings at the cost of \$60 per horse stall, including disposal. Shavings will be available in 2 locations on the fairgrounds. Each horse stall will be bedded upon arrival, check in at office for details. We ask that you use discretion when bedding your horse stalls throughout the 4 days of the show, in the event the bulk shavings run out, baled shavings will be available for purchase (price to be determined at show).

Those wishing to be stabled together **MUST REQUEST THIS ON THE ENTRY FORM AND GET THE ENTRIES IN EARLY AND TOGETHER.** Stalls must be paid as a whole. **Trainers splitting the cost of stalls with their clients must make these arrangements personally and not through the Show Office.**

Stall fees are based on stabling available from 8:00am Tuesday July 29 to 9:00 pm. Sunday August 3. ABSOLUTELY NO HORSES WILL BE ALLOWED ON SITE PRIOR TO TUESDAY AT 8:00am without notification of the show secretary. Set ups are allowed to begin after noon on Monday July 28. Please notify the Show Secretary ahead of time if you will need stabling either before or after these dates. Early or late stabling (horse hotel) will be charged at \$30 per night. Payment must accompany entries or the stalls will not be reserved. **The stall chart will be posted on the guard booth at the entrance of the facility. Stall assignments are determined by years of participation and financial support. Stall fees must accompany all entries. Please indicate by name, on stall request, if you wish to be stabled near someone.**

Dressage Only Stabling will be available from **8:00am Tuesday July 29 to 8:00pm Thursday July 31.** The stabling fee will be

\$60 per day, including bedding, payable with entry. These stalls are located on the outside of barn 105.

HAUL IN: Fee of \$25 per day, will be charged (per horse) for those showing out of their trailers. Horses may not stay in trailers overnight and must be attended at all times. Please check in at the Show Office.

YOUTH OF THE YEAR CONTEST DETAILS/SCHEDULE WILL BE AVAILABLE AT SHOW OFFICE ON JULY 30.

AWARDS: Ribbons will be awarded through 6th Place, except for Junior Exhibitor classes which will be awarded through 8th Place. Championship classes will be awarded ribbons through 6th Place.

HIGH POINT JR EXHIBITOR PERPETUAL TROPHY Sponsored by Chandel Morgans, Dean and Pam Ellingsen, Smithville, MO. This Perpetual Trophy to be awarded to the High Point Junior Exhibitor of the C-Fair Benefit Horse Show. Classes to count: All Junior Exhibitor Performance classes, i.e., Western Pleasure, English Pleasure, Hunter Pleasure, Pleasure Driving and Classic Under Saddle and Driving (no open classes to count); Showmanship, Equitation including Medal Classes. Points to Count 8,7,6,5,4,3,2,1. The classes will be calculated on a one horse; one rider combination. In other words, you can ride more than one horse, but points will not be combined. Points will count for same horse same rider in any combination of disciplines, i.e., same horse and rider in Western, Hunter, Driving, English Pleasure and Classic.

HIGH POINT WALK-TROT TROPHY: All Walk-Trot classes to count. One rider, one horse combination. You can ride more than one horse, but points will not be combined. Points to count 8,7,6,5,4,3,2,1.

COVID-19 ACTION PLAN The USEF requires competitions to operate in accordance with state and local requirements. In the absence of state or local requirements, USEF recommends compliance with CDC guidelines. To mitigate the risk of spreading COVID-19, competition management can impose more restrictive requirements if they so choose. As requirements change frequently, show management will post all COVID-19 requirements under which our competition will operate. All persons attending Key Classic Benefit Horse Show are responsible for reviewing and complying with the posted requirements. Individuals may choose to wear a face covering/mask even when it is not required. Anyone choosing to wear a face covering will not be penalized for doing so.

MORGAN ELIGIBILITY: Horses shown in this division must be registered with the American Morgan Horse Association, Inc., or an organization having registry reciprocity (Canadian Morgan Horse Association, British Morgan Horse Society, Swedish Morgan Horse Society). Horses must be entered under their full registered name or if under one year of age be eligible for registration. Horses must be entered under the names of the owner(s) or lessee of record. A copy of the registration papers showing recorded ownership or proof of lease must be submitted with entry form at the time of making entry. Competition management is responsible for notifying exhibitors of this requirement. Owners (lessees), riders, drivers, handlers, coaches, and trainers of horses participating at Federation licensed competitions in all Morgan sections must be current members in good standing with the American Morgan Horse Association, Inc.,

or an organization having registry reciprocity (or pay a non-member fee. Set fees shall be payable to AMHA.) An original or a copy of the membership card must be provided to the competition unless the competition, at their discretion, confirms membership electronically with one of these organizations. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownerships, only one owner need be a member. Exceptions: Exhibitors in Leadline and/or Walk-Trot classes are exempt from this membership requirement. Additionally, a parent/guardian when only signing an entry blank for a minor is not required to be a member or pay a non-member fee

AMATEUR NON-MEMBER: Amateur cards are no longer available for non-members. Only active Federation members may obtain amateur certification. Every person who has reached his/her 18th birthday and competes in classes for amateurs under Federation rules must possess current amateur certification issued by the Federation. (Exception: This is not required for Opportunity classes except Dressage) (GR1307)

EVERGREEN STATE FAIRGROUNDS RULES AND REGULATIONS

To ensure a smooth and successful show, all exhibitors are asked to read and adhere to the following rules. Blatant disrespect of the rules may constitute grounds for elimination.

NO SMOKING IN THE ARENA OR BARN

DOGS ARE PERMITTED ON THE FAIRGROUNDS – ON LEASH ONLY when not in personal RV or vehicle. Owner must maintain control of the dog at all times. Owner must clean up after dog. Dogs will only be allowed in the grandstand of the main arena and NOT allowed ringside at any of the warm-up rings or outdoor arenas. Dogs that cause disruptions must be removed from the fairgrounds or secured in a vehicle. Show management and fairgrounds officials have the authority to enforce these requirements. Fairgrounds personnel or show management have the authority to summon a Park Ranger or County Animal Control if deemed necessary

PARKING AREA (BY ORDER OF THE FIRE MARSHAL): Vehicles may not be parked within 100 feet of the barns. Vehicles in the barn area must be loading or unloading only.

BLOCKING OF BARN EXITS & AISLES (BY ORDER OF FIRE MARSHAL): Decorations, signage or temporary structures may not cover or block any building exit aisle way or cover any fire extinguishers, fire hoses, phones or electrical panels.

BARN: The fairgrounds does not allow stall front/panel removal. Under no circumstances is one permitted to disassemble any of the

stalls or parts of the barn. To do so will jeopardize further use of the facilities by our show.

OUTSIDE BARN DECORATIONS: Request to display decorations outside the barns should be submitted to the Evergreen State Fairground, one month prior to set up.

ARENA FOOTING: Main Arena – 120' x 246', Dirt; **Outdoor Warm Up arena** – 128 x 254', Sand; **Covered Warm Up Arena** – 100' x 200', Sand; **Sport Horse Arena 109** – 120' x 200', Sand; **Arena Between Barns 105 & 106** – 73' x 164', Sand. In addition, several sand lunge rings.

MOTORIZED VEHICLE STATEMENT: In accordance with USEF GR1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

PLEASE ALSO REFER TO THE EQUESTRIAN PARK RULES AND REGULATIONS WITH REGARD TO OPERATION OF MOTORIZED VEHICLES

NO SCOOTERS, SKATEBOARDS, BICYCLES, ROLLER BLADES, MOTORIZED CARTS AND MOTORBIKES. From Snohomish County Risk Management Office: **These vehicles are not allowed on the fairgrounds and will be confiscated until end of show.**

3. A horse/pony may be shown in one or more Classic qualifying classes; however, the Declaration and Starting Fees must be paid for each Classic class in which it will be shown.
4. All entry fees, or partial entry fees, are added to the total purse of the class.
5. Fees are non-refundable in all situations.
6. All USEF rules apply.

1. Roadster Horses: In order to compete all horses must be a Standardbred or Standardbred type. Roadster Ponies are not permitted to compete in Roadster Horse classes.
 - a. All horses competing in Federation Licensed Competitions must be properly identified and must obtain a Roadster Horse Identification number from the American Road Horse and Pony Association (ARHPA). An ARHPA Roadster Horse ID number for each horse must be entered on all entry forms for licensed competitions.
 - b. Only one unique ARHPA Roadster Horse ID Number will be issued per horse. This unique ID number must subsequently remain with the horse throughout its career. Anyone knowingly applying for a duplicate ID Number for an individual horse may be subject to disciplinary action.
 - c. The Federation and/or ARHPA as applicable must be notified of any change of ownership and/or competition name of the horse. Owners are requested to notify the Federation and/or ARHPA as applicable of corrections to previously submitted information, e.g., names, addresses, breed registration, pedigree, or markings.
 - d. The ARHPA Roadster Horse ID application is available from the ARHPA or the Federation office, or it can be downloaded from the ARHPA or Federation website or completed in the competition office. Competition management is responsible for notifying exhibitors of this requirement in their prize list.

Owners, riders, drivers, and trainers of horses participating at Federation licensed competitions in the Roadster Division must be current members in good standing with the American Road Horse and Pony Association. Originals or copies of the above listed membership cards must be provided to the competition unless at its discretion the membership can be confirmed electronically with either the AHHS or the ARHPA office. Lessees are considered owners in connection with these membership requirements. In the event of an entry under multiple ownership, only one owner need be a member of the required organization. Except as may otherwise be mandated by local law, protective headgear is strongly recommended for everyone showing in any class in the Roadster Division as outlined in GR801.4, .7 and .8. Except as may otherwise be mandated by local law, while riding or driving anywhere on the competition grounds, all juniors riding or driving in Roadster to Bike or Roadster Under Saddle classes must wear properly fitting protective headgear which passes or surpasses ASTM (American Society for Testing and Materials)/ SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag as specified in GR801. Harness must be secured and properly fitted. A matching cover may be worn over the protective headgear or the protective headgear may be painted in matching stable colors. See USEF RD101 through RD113 for full specifications.

FRIESIAN DIVISION

Horses shown in this division must have been issued a membership certificate from the International Friesian Show Horse Association (IFSHA) confirming verification of Friesian heritage and identity with IFSHA. **IFSHA will no longer accept new horse applications or new horse owner applications at a horse show. All participants must provide the show secretary proof of membership of both the owner and the horse prior to coming to the show. This is necessary to make sure that all participants are treated equally. We have had issues with members and horses joining at a show without the proper registration paperwork and then being able to show. After the show, we then have to find these people and chase them down for their registration papers. We feel that this is not a burden that should be upon either the show secretary or the IFSHA office.**

Exceptions to this rule will be reviewed on a case-by-case basis by the Executive Director of IFSHA. To review both members and horses must provide prior to the entering the show ring a copy of their IFSHA membership and a copy of their horses IFSHA membership to participate in the show. Refer to FR 101.2

Horse Owners/Lessee's competing in Purebred & Part-Bred Friesian USEF licensed competitions recognized by International Friesian Show Horse Association (IFSHA) must be members in good standing with the IFSHA. In order to compete, horse owners/lessees must provide a copy of their IFSHA membership card and a copy of the horse's IFSHA membership certificate with entry form. Any Friesian bred horse regardless of color, height and/or registry that can prove it's Friesian heritage and identity is eligible to compete provided the horse and the horse's owner/lessee are IFSHA members in good standing and the horse has been issued an IFSHA membership certificate.

Individuals signing the USEF Entry Agreement (i.e., rider, driver, handler, trainer or agent of an owner) for horses competing in the Friesian division must be members of IFSHA or pay to IFSHA a non-member fee. Horse owners/lessees must be members of IFSHA as required in FR101.1a. Exception: A parent or guardian signing for a minor does not need to be an IFSHA member nor pay the non-member fee.

IFSHA and its assigns reserve the right to validate the horse DNA at the horse owner's expense in the event that a protest or grievance has been filed with IFSHA and/or the USEF. Part-bred Friesians must have at least 50% pure Friesian blood and one pure blood Friesian parent.

Riders compete at the walk, trot and canter both ways of the ring, line up, and a minimum of the top four (4) riders must be worked individually at the mandatory workout; more may be worked at the judge's discretion. Showmanship is a primary factor throughout the class, therefore, "Show Your Horse" is no longer a necessary or acceptable test. The mandatory workout in all qualifying competitions (except Walk/Trot classes) is: "Trot a serpentine to the opposite end of the ring. Return down either rail at a show trot." The proper calling of the gaits shall be "walk, show trot and canter". One UPHA Challenge Cup win eliminates that rider from further competition in qualifying classes that season, with the exception of the 11 and Under age group See USEF Subchapter EQ-3, EQ118.17e.2. Judging

is based on 60% rail work and 40% on the individual workout. The first four places are eligible for the Chapter Championship. The winner of this class is also eligible for the UPHA National or Junior Challenge Cup Championships. See USEF EQ118.17b Open to Mares & Geldings only. Horses to be fitted and shown according to breed type. Showman to demonstrate ability to lead, move, and turn his/her animal and perform other tests as the judge directs. Only one exhibitor shall be allowed in the ring to show each horse. English or Western must be designated on entry form.

To be shown at a walk, trot, road trot, canter, hand gallop both ways of the ring and to back readily. At any time during the class the judge may ask horses to halt and walk off on a loose rein. Excessive speed at the hand gallop should be penalized. To be judged on performance with proper cadence and balance, manners and suitability for a road hack 60%; type and conformation 40%

- 122 Bridle Path Hack, OTAB
Hunter type horse to be shown at a walk, trot canter and hand gallop both ways of the ring. To back easily and stand quietly while rider dismounts and mounts. Emphasis is placed on actual suitability to purpose.

- 197 Show Hack, OTAB
Competitors to enter the ring in a counterclockwise direction at a normal trot. Horse must have natural action. Elevation and high knee action are not to be emphasized. Horses must be balanced and show vitality, animation, presence, clean fine limbs and supreme quality typical of the breed shown. Soundness is required. Light contact must be maintained with all reins at all gaits. Horses may be shown with a braided mane and tail. Braids may be secured with tape, yarn, or rubber bands. Decorations are prohibited. Bridle shall be light, show type; either snaffle, double (full) or pelham. Kimberwicke bit is permitted. Browbands and cavesson other than dressage types are prohibited. Unconventional tack such as figure eight, drop, or flash nosebands are not permitted. English saddle of any type is required. Girths of either leather, white web, nylon string or suitable material. Martingales, breastplates not allowed. Acceptable Hack attire is required. It consists of conservatively colored coat, breeches and boots. A conservatively colored hunting cap or derby is required. Formal attire consisting of white breeches, top hat and tails may be worn. Spurs, whip or crop optional at the exhibitor's discretion.

GAITS: WALK - a four beat gait: Straight, true and flat-footed. TROT - a two-beat gait: Free-moving, straight, rider maintaining light contact with the horse's mouth at all times. CANTER - A three-beat gait: Straight on both leads, smooth. Normal, collected and extended gaits to be called for both ways of the ring. Rider will post the normal trot, sit the collected trot and post the extended trot. Refer to USEF NS148-NS151. At the discretion of the judge, horses while on the rail may be asked to halt and rein back. Horses shall be able to perform all of these gaits with a noticeable transition between the normal, collected and extended gaits. Horses must appear to be under complete control and easily ridden. Obedience is of prime importance. To be judged on performance, manners, quality and conformation. NOT USEF.

174 Lead Line, Riders 8 years and Under – OTAB

****ONE RIDER PER MOUNT**MINIMUM AGE OF RIDER 2 Years**

Open to beginning riders who are at least 2 but less than 7 years old (GR103) and disabled riders on mares or geldings. To be led from the ground. The leader must be at least 16 years old (USEF GR103). Safety is of the utmost importance in presentation, tack and attire. It is required that equipment fit the rider with rider's feet in the stirrups. Failure to comply will result in elimination and the entry will be asked to leave. Attire of the rider shall include Saddle Seat, Hunter Seat, Western Seat, Dressage Seat, Side-Saddle, or Roadster silks. Protective headgear must be worn by riders in lead line classes at all times while mounted. (See USEF GR801 EC Eff 03/21/11). Rider and leader's apparel does not have to match. The rider should be in control of the reins, but the leader must hold a lead that is attached to the bridle/headstall appropriate to the saddle used. To be shown both ways of the ring at a walk only. Riders may not be tied in the saddle in any way. Riders may be lined up side by side or head to tail. Not to mount or dismount. Entries will not be asked to back. Judged on seat, hands and general horsemanship. Suitability of mount to rider to be considered. No cross entry to any other ridden/driven class in this show. NOT USEF.

Costumes welcome; non-traditional attire permitted. Maximum of 4 minutes per horse/rider; music must be submitted to show office by Friday at noon. Check with show secretary for required format for music.

RANCH PLEASURE – OPEN TO ALL BREEDS

The purpose of Ranch Pleasure should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse working outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward, working speed while under control of the rider. Light contact should be rewarded and the horse shall not be shown on a full drape of reins. The overall manners and responsiveness of the horse while performing the maneuver requirements and the horse's quality of movement are the primary considerations. Horses should NOT perform or be rewarded for performing gaits as they do in Western Pleasure. The horses are to be presented in a more forward-moving style than the typical Western Pleasure horse. The horse and rider will be scored on movement, which is cadence and rhythm of gaits, smoothness and consistency in performance, along with how they perform on the optional maneuvers. For rules regarding correct Western appointments, refer to MO132. The required gait maneuvers will include the walk, jog, and lope of both directions; and the extended jog and extended lope going at least one direction; as well as stops, and a back. Optional maneuvers are side pass, turns of 360 degrees or more, change of lead (simple or flying), walk, jog or lope over a pole(s); or some combination of maneuvers that would be reasonable for a ranch horse to perform.

- RANCH RIDING: Each horse will work individually, performing both required and optional maneuvers, and scored on the basis of 0 to 100, with 70 denoting an average performance.

- RANCH PLEASURE: Horses will work as a group on the rail and will be asked to perform the required maneuvers only. The overall cadence and performance of the gaits should be free-flowing and ground covering at all gaits, with an emphasis on forward movement. Transitions should be performed where designated, with smoothness and responsiveness.

Horses may be ridden in English or Western tack. Trail horses are required to work over and through obstacles. No horse may enter the trail course area until the course and the judge are ready. Riders will be permitted to inspect the course on foot during the Judge's instructions prior to the start of the class. Tests which may be required are negotiating gate, carrying objects from one part of arena to another, riding through water, over logs or simulated brush, crossing a bridge, backing through obstacles, side passing, and performing over any reasonable conditions encountered along the trail. Course to include a minimum of six obstacles. Two or more horses may be entered by the same exhibitor and the same rider may elect to show more than one horse. Obvious unsoundness must be disqualified with no prize awarded. Rail work shall not be required.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter; as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:
